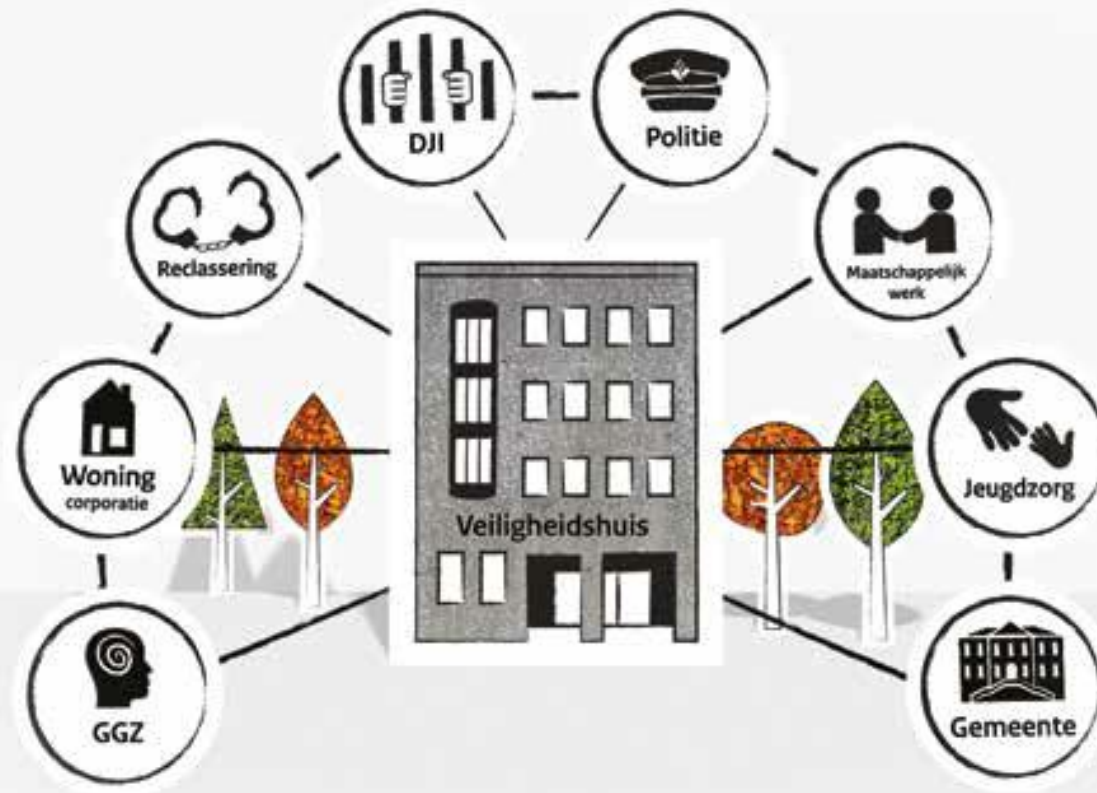


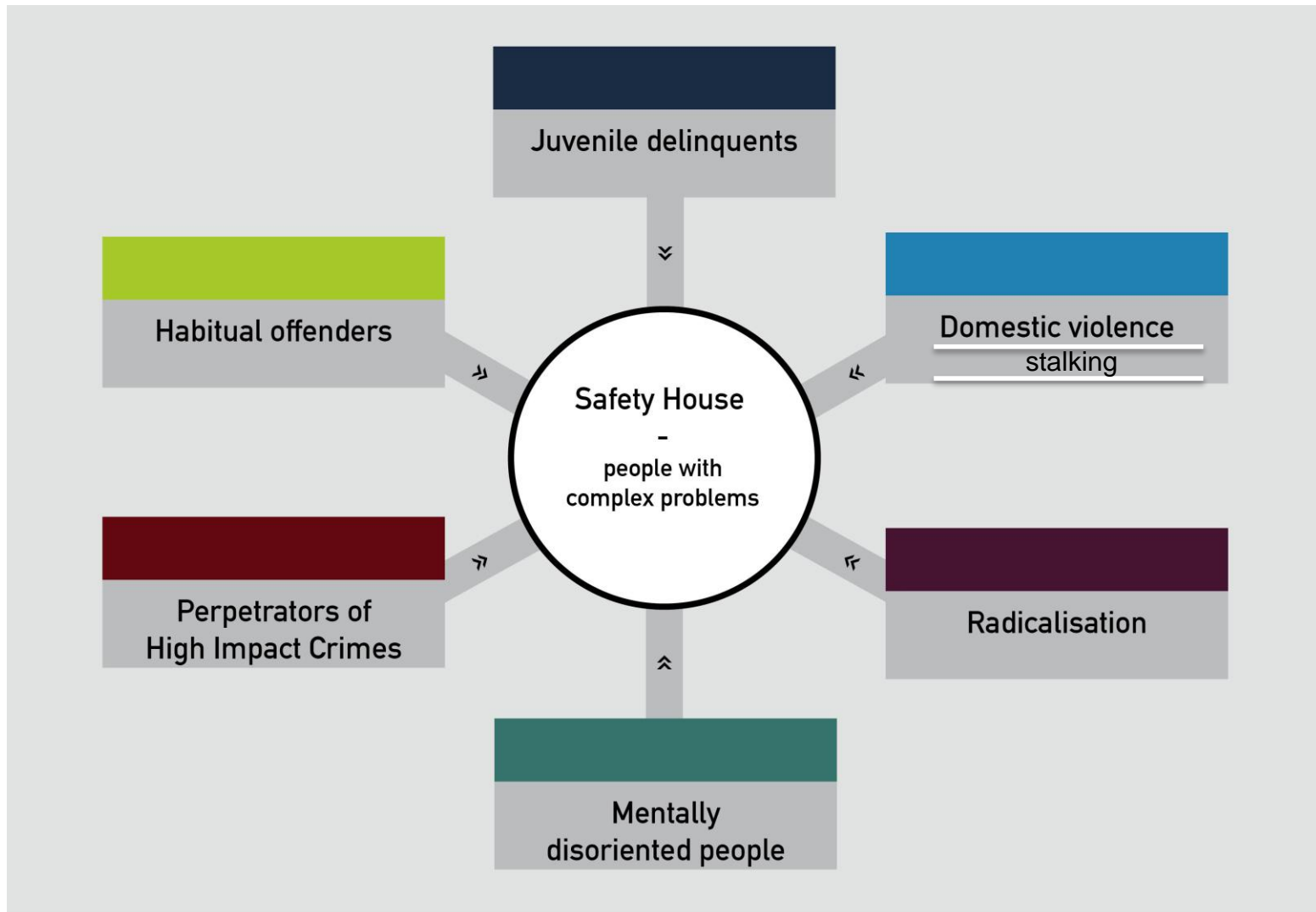

Domestic violence → stalking, a wicked problem

Deadly violence is no exception

Stalking not always recognised

Action on 1 incident at a time, but it is a serie of incidents!

Analyses not in order

Risc judgement not in order

Safety of the victim....

Not enough knowledge of stalking



Risc profiling: checklist

More than 2 weeks?

Investing a lot of time, energy, costs?

Was there a intimate relation? Marriage?

Previous use of violence?

Does the stalker say he is in distress?

Does he threatens with murder or suicide?


Is he into weapons?

Is he in outrageous anger?

Did he distroy goods of the victim?

Rating of fear by victim

Security house Rotterdam, police, Veilig Thuis (Safety at home, organisation which coordinates help in case of domestic violence) public prosecutors office.

Our goals:

We want to recognize stalking as early as possible

We want to reduce the risks (violence) and make a good risk analysis

We want to take the right actions

1 plan on stalking, together.



How?

- 1) Education of professionals
- 2) Sharp work processes police, safety at home organisation, safety house, prosecutors office
- 3) Risk analyses and proper actions
- 4) Case consultancy meetings --> action!

- A multidisciplinary action plan aimed at the subject + victim

Teamwork: feel responsible

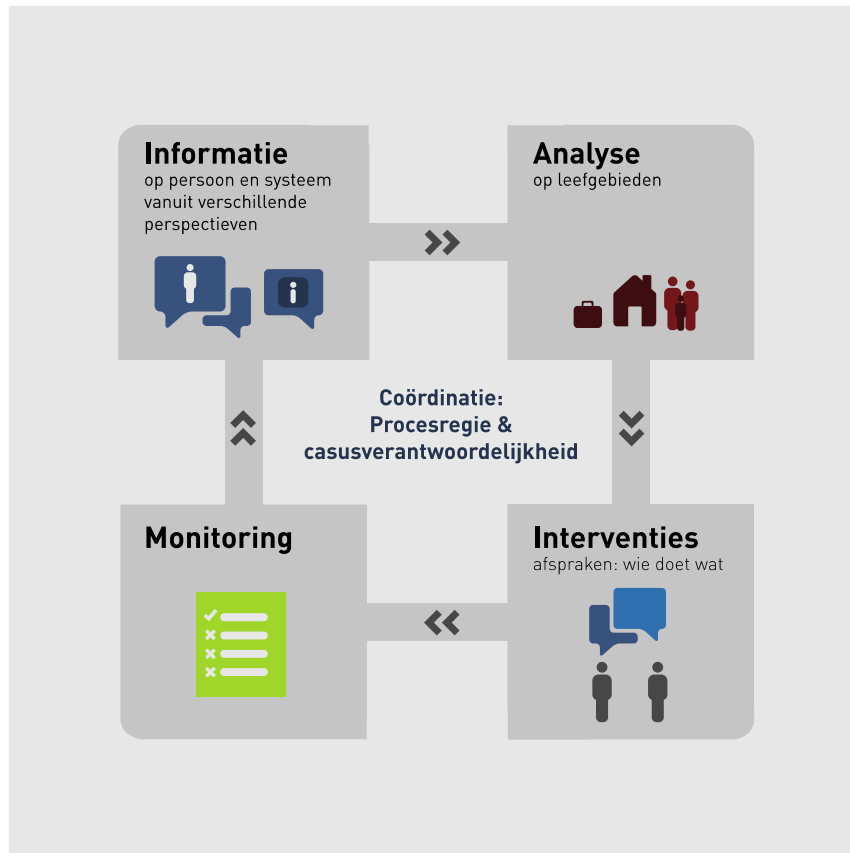
One approach
